The Executive Summary conveys the plans of Ohio State University Extension (OSUE), the Ohio Agricultural Research and Development Center (OARDC) and the College of Food Agriculture and Environmental Science (CFAES) for 2014-2018. The new Dean and Vice President of CFAES is Dr. Bruce McPheron, who will be leading the statewide efforts in the research and extension mission. An important part of this effort will be the OSU Discovery Themes which are intended to guide and better integrate these efforts across all of OSU. The three Discovery Themes are (1) Health and Wellness; (2) Energy and Environment; and (3) Food Production and Security. CFAES has three signature areas: (1) food security, production, and human health; (2) environmental quality and sustainability; and (3) advanced bioenergy and biobased products. These areas are consistent with Challenge areas within the National Institute of Food and Agriculture (NIFA). CFAES is in the initial stages of Advancement planning, which will support the college's strategic plan and campaign plan and expand connections with alumni, friends, and stakeholders. Government relations and industry relations are also part of the plan. The Executive Summary lists a few important investments that will be taken by OSUE and OARDC during the planning period. OSUE and the Vice President for Agriculture to obtain input and guidance. There are also linkages with county, regional and statewide groups. In addition, each academic unit has subgroups of stakeholders based on the needs of their research and extension programs.

- 2. The needs of under-served and under-represented populations of Ohio: OARDC and OSUE are continually building linkages to under-served groups. They describe numerous methods for identifying underserved and under-represented groups. They create a community that focuses on building a culture of acceptance and appreciation of diversity.
- **3.** How expected outcomes and impacts will be described: OSUE and OARDC will continue to evaluate all programs based on outcomes and impacts by assessing new scientific knowledge gained, behavioral changes of clientele, and change actions in practices and resultant products. The outcomes are expected to impact Ohio, the nation, and the world, especially by growing the economy, creating jobs, improving food security, reducing world hunger, moving toward more energy independence, and mitigating the impacts of climate change and other environmental problems.
- **4. Improving program effectiveness and/or efficiency**: Planned programs will ensure effectiveness by continued and enhanced focus on assessing stakeholder needs while assessing the institution's capabilities within mission to meet those needs. Efficiencies are also gained by predetermining where scarce resources are to be targeted and what impacts are expected based on the inputs allocated. Strategic plans and external program reviews will provide additional insight into program planning.

CFAES, OARDC and OSUE are guided by strategic plans that were developed with extensive stakeholder input. OARDC, OSUE and academic departments within CFAES have external advisory committees that meet 2-3 times per year to discuss current programs and provide input for future directions. All county extension offices have overall advisory committees and focused committees.

The seventeen programs in the Plan of Work are well justified. Appropriate outputs and outcomes are listed. It is useful to have information about how the planned programs are integrated with the CFAES signature areas and the OSU Discovery Themes. It seems that most of the planned programs are important to all of the signature areas and all of the Discovery Themes.  A bit more editing of the brief summaries of planned programs would be helpful. For example, The Soil, Air and Water Program summary contains several references to "Global Food Security" when it should be "Soil, Air and Water." This was clearly a "cut and paste" problem. Also, the text contains several misspellings, including a statement in the Agricultural, Environmental, and Development Economics Program summary that indicates that "The faulty group leading the research" I suspect it should have referred to the faculty group. The write-up for the Sustainable Energy Program mentions the development of shale natural gas in Ohio but a more thorough treatment of this issue and how it will influence or not influence the Sustainable Energy Program would have been helpful.  All in all, the 2014 Ohio State University Combined Research and Extension Plan of Work is well written and planned programs are appropriately justified. Planned evaluation studies are extensively described.				
General Recommendations:				
This Plan of Work describes seventeen planned programs. They are well justified. The knowledge areas are appropriate. Appropriate outputs and outcomes are described for each program.				
We hereby recommend NIFA acceptance of this Plan of Work.
