Judging, Food and Nutrition Judging, Clothing and Textile Judging and Style Revue, Awards assembly for judging events, and the Mahoning County PAS Show. Following the judgings, will assist the 4-H educator with entering the information for the state qualifiers.

- Good-Natured Garden Partners/Local Flavor Program: Assist with training and scheduling of volunteers to assist and plan year-end Garden Party event, work with youth involved in the program.
- Junior Master Gardener Program Assist in designing the teaching sessions using the Junior Master Gardener Curriculum and recruiting new members. This is an urban outreach program so will be recruiting within the city of Youngstown. Work with the Master Gardener Leaders of this program.
- Summer Field Days Work with the ANR Program Coordinator to implement four summer field days, including energy technologies on the farm and nutrient management. Work with area farmers as they gain fertilizer certification.
- STEM in the City: Work with OSU Extension educators and established partners (MCCTC, YNDC, City of Youngstown) to develop ideas for STEM-based activities throughout the city of Youngstown, as well as Campbell and Struthers.
- Promotion of 4-H in Mahoning County: Promote 4-H activities (such as; camp, judgings, PAS, programs, etc.) through the use of our county web page, social media, flyers, emails, media releases, news media, etc. Make the 4-H program visible to all in the county for residents to have a better understanding of what 4-H is and how to become involved in the program.
