#### Workforce Development

- County Plan of Work Project "Adulting is Hard" program the intern with county team
  to develop a program for seniors in High School. This will be a refresher program
  targeting seniors in Pickaway County. All eighth graders in the county attend Real
  Money Real World programs and this effort will entail a shortened version focusing
  on the next steps after graduation. Community partners include Pickaway WORKS
  and the Pickaway County public library. Work with county team to develop the project
  for implementation in 2019.
- 4-H Project judging work with judges at the Clothing Project judging. At Style Revue, assist FCS educator with awards, ribbons, and present awards.
- Work with 4-H educator on Special Interest project judging and Food, Nutrition, & Creative Arts judging including awards, and ribbons.
- 6. List a minimum of six activities in which the intern will participate. These activities and meetings should be within the impact areas, across program areas and/or with the community or other professionals.
  - Attend Family & Children First Council meeting on June 12, 2019
  - Meet with Live Healthy Live Well team leaders to discuss the team projects.
  - Meet with Style Revue Committee to plan the 2019 Style Revue at the fair.
  - Prior to the fair, design the Style Revue program. Work with local volunteers and educators to decide and create theme for the Style Revue including decorations and set up/management of the program.
  - At the county fair, assist and coordinate the set-up of the Style Revue.
  - Meet with community partners and the Pickaway County staff to work on the County Plan of Work Project. Community partners include Pickaway WORKS staff and library personnel.
  - Research information for the "Adulting is Hard" (County Plan of Work project).
  - Meet with Pickaway County staff to plan food demonstrations for three series of youth cooking programs.
  - Work with FCS educator on Cloverbud activities for the Pickaway County fair. At the fair, meet community partners on the designated dates, recruit participants for youth activities and distribute ribbons.
  - Work with 4-H educator on project judging during fair week.
