- Junior High 4-H Camp participate in camp June 18-21 at Canter's Cave 4-H Camp in Jackson; will assist with camp preparation and registration; will develop a lesson based on individual area of interest and teach at least one session at camp.
- Cloverbud Day Camp will create a session based on personal area of interest; will teach the session and work with teen counselors to assist in delivering the program. July 10
- 4-H Project Judging will contact judges; prepare judges packets; with assistance from 4-H Educators will organize awards and ribbons, announce results, and present awards. July 16-17
- Publicity Informational Materials will create news articles and website posts based on the work done by OSU Extension as it focuses on the six impact areas; articles may be published either during intern's placement or after the placement has been completed; articles will highlight existing personnel and programs which are currently being taught within the county. Additionally, the intern will create a promotional video for Scioto County 4-H and 4-H Camp. The intern will record videos during events and then compile them into a professional video to utilize in the community, local schools, etc. in the coming year.

Jo Williams has been a 4-H educator for 18 years and has worked in two counties. She has handled all aspects of the 4-H Youth Development program over her career. The office has a second 4-H educator that the intern would also work with, so they would get a full experience of all aspects of the 4-H Program, as well as working on a couple of FCS and Ag projects. The Scioto County office houses a staff of 11, with five educators in 4-H, Ag and FCS. The team of educators routinely collaborate on projects to meet community needs. The intern would be able to experience a wide variety of programming and participate in planning sessions for those programs, as well as program delivery.
